GERMAN CANADIAN CONCOURSE

Arrangements for your Participations

1. The German Canadian Concourse (“GCC”) is a brand of Canada Meets Germany Network e. V. (the “Organizer”, address: Schnitterweg 7, 65207 Wiesbaden, Germany), a non-profit association registered in Germany. The Organizer operates the GCC in cooperation with institutional and corporate partners and is responsible for the event and program.
2. The GCC takes place in Germany and in Canada. The format usually comprises a conference part (Transatlantic Symposium), which connects both hub locations in Germany and in Canada, Field Trips to a local partner organization/company, and Networking Receptions.
3. These arrangements are intended to define some agreements and understanding for your participation in the GCC. Participation in the GCC is subject to registration and admission by the Organizer. By submitting a registration, you as a participant accept these arrangements for your participation.
4. The Organizer reserves the right to modify the course, the contents, the title and the date of the event, and the right to cancel the event. The Organizer does not accept any responsibility for losses related to such decisions. In the case of cancellation of the event, the Organizer shall reimburse the ticket price (of ticket fees were collected) but shall not be liable to further claims.
5. It is intended to set up a video link to connect the hub locations in Germany and in Canada during the conference, which shall be accessible online during the event and made available for download on the website following the event. Photographs might be taken during the event and might be published on the website following the event. It is also envisaged to prepare a White Paper, which is a summarized recording of the proceedings of the event. You agree that your image and your contributions to the event might be visible, accessible or recorded in this context. You furthermore agree with the **Privacy Policy** of the German Canadian Concourse.
6. The Organizer will bear no responsibility for accidents or injuries, loss, theft or any other damages, unless stipulated otherwise below. The Organizer shall be liable, without restriction, for intent and gross negligence as well as in the case of personal injury. With regard to slight negligence, the Organizer shall only be liable for a breach of essential obligations. Liability for breach of such essential obligation shall be limited to the typical damage that the Organizer should have been able to foresee. The aforementioned limitations of liability shall not apply in the case of an assumption of express guarantees by the Organizer and for damage arising from injury to life, limb or health, for claims under the German Product Liability Act (*Produkthaftungsgesetz*) and in the case of mandatory statutory regulations.
7. You are liable for any breach of third-party rights and for any breach of legal provisions or requirements committed by you. For any such breach, you undertake to indemnify and hold harmless the Organizer against all claims for damages raised by third parties.
8. The relationship between the Organizer and the Participant shall be governed by German law. The place of jurisdiction for all disputes shall be the registered seat of the Organizer.



Privacy Policy

1. By registering for the German Canadian Concourse (“GCC”) you agree that your personal data may be used by the Organizer its partners for planning purposes and to grant you access to the conference site. You furthermore agree that your name, position and company as well as details about the expertise which you are offering / searching at the GCC may be added to the list of participants which will be published in the conference brochure. Your contact information (address and email address) will not be revealed to any other party and will be used by the Organizer only to communicate information regarding the conference, unless you explicitly agreed to be part of the match-making process or that your contact information may published for instant messaging during the event.
2. If you have agreed to take part in the match-making process, the Organizer may propose other participants at the symposium to contact you (during the event or as follow-up) on the basis of matching interests derived from the information that you provided at registration. In particular, your contact information would be provided to selected participants in the match-making process. The organizer may sub-contract the assessment of matching interests of participants to a consultancy firm; in this case, the registration information of participants of the match-making process will be provided to the consultant for the exclusive use of the match-making assessment.
3. By attending the German Canadian Concourse, you agree to the usage of photo and video material of you recorded during the event for online publication and publication in print media by the GCC organizers for promotion of this event and future events. You further agree that the GCC organizers may host the photo and video material on external platforms (e.g., YouTube, LinkedIn, Twitter, Flickr, Facebook ...).
